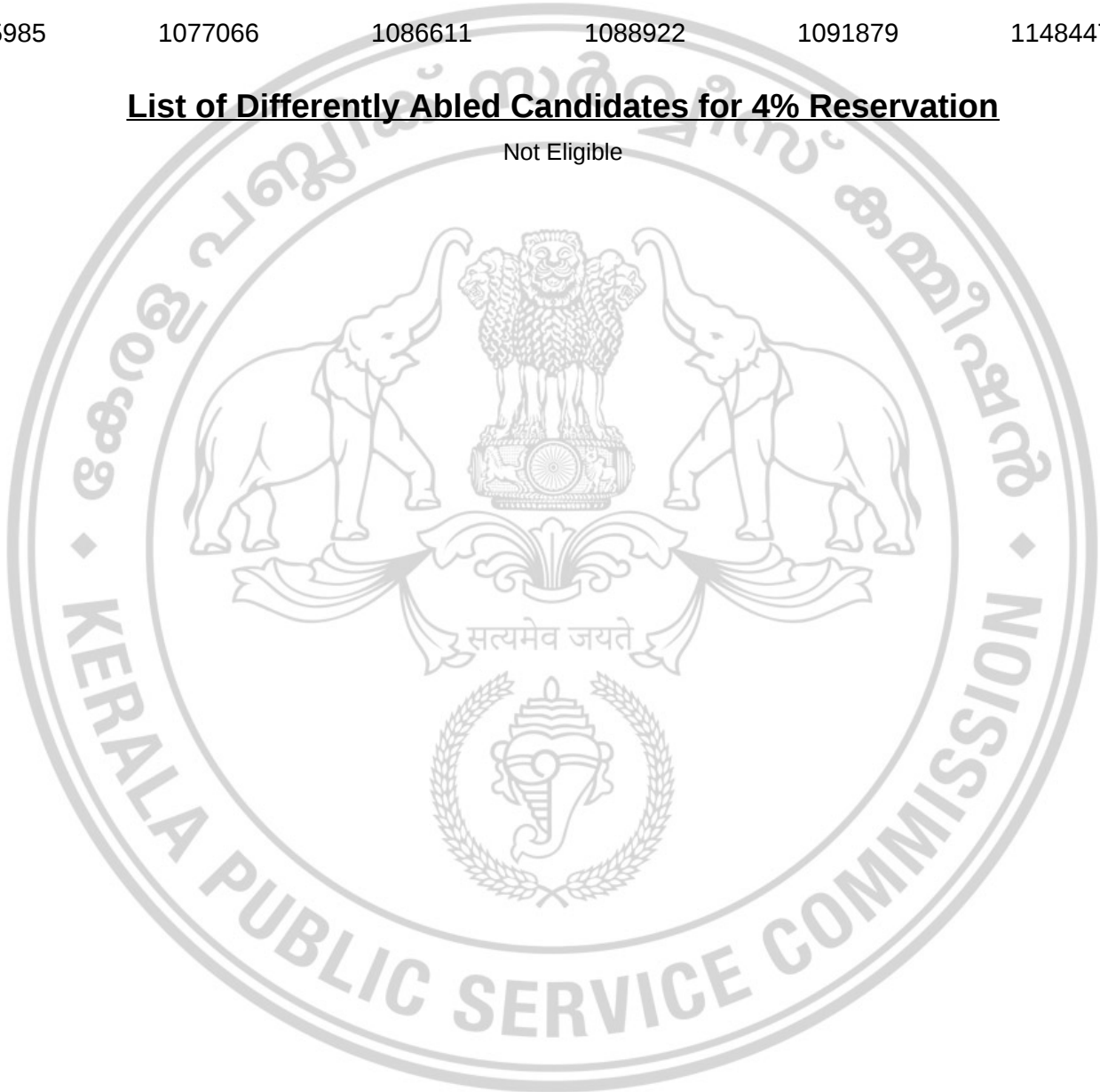

Note:- (2) The list has been prepared by including the register number of candidates who have secured top marks in the OMR test.

Note:- (3) **149** candidates who have secured topmost marks in the OMR Examination are included in the Main List of this Short list. The Marks secured by the last candidate in the Main List is **50.00 (Fifty (point) Zero Zero)** For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of candidates belonging to such classes.

Note:- (4) Candidates included in the Short List should appear in person and produce their Admission ticket, medical certificate (Format prescribed in the Gazette Notification) & original ID Proof for the Endurance Test. **Date, Time and Venue of Endurance Test will be intimated through SMS, Profile Message and through Print and Electronic Media.** The shortlisted candidates should download their admission tickets for the Endurance Test from their OTR profiles.

Note:- (5) Candidates included in the Short List , eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009, SC/ST candidates included in the Short List are required to produce Community Certificate (Form III/Digitally signed) issued by the competent Revenue Authority and those belonging to Economically Weaker Section(EWS) are required to produce EWS Certificate in the format prescribed vide GO (MS) No.2/2020/P&ARD dated.12.02.2020 in proof of their claim along with other relevant documents.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (7) Copy of answer scripts of the OMR Test held on 23-05-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers invalidated are advised to refer to Notification No : ER 7-1/5/2026 - KPSC dated 06.08.2026.
