Note:- (3) **31** candidates who have secured top marks in the OMR examination are included in the Main List of this Probability List. Out of the 31 candidates in the Main List, the lowest mark secured to be included in the Main List is **71.6700 (seventy one (point) six seven zero zero)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes, Other Backward Classes, Economically Weaker Section (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. Date,time and Venue of One Time Verification will be intimated in due course through profile Message and SMS.

Note:- (5) The register number of those candidates who do not produce the required documents with the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note:- (6) Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non Creamy Layer Certificate as per GO(P)No.81/09/SC/STDD dated. 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST Candidates are required to produce Community Certificate (Form III / Digitally Signed) issued by the Revenue Authority not below the Rank of Tahsildar and candidates claiming reservation under EWS category are required to produce EWS Certificate vide GO(Ms) No.2/2020/P&ARD dated 12.02.2020//GO(Ms) No.5/2020/P&EA dated 04.03.2020 (for public sector undertaking issued by the Revenue Authority along with other documents at the time of One Time Verification of original documents.

Note:- (7) Copy of answer scripts of the OMR Test held on 10-06-2026 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated as per Notification No : ER2-3/9/2026-KPSC Dated.05/08/2026.
