Note:- (4) The Date, Time and Venue for the Physical Measurement and Physical Efficiency Test will be intimated to the shortlisted candidates in due course through SMS and Profile message. The shortlisted candidates should download their Admission Ticket for Physical Measurement and Physical Efficiency Test, from their OTR profile, logging on to the official website, www.keralapsc.gov.in of the Kerala Public Service Commission and appear in person with their Admission Ticket, original ID Proof and Medical Certificate (in the form prescribed as per the Gazette notification) at the time of Physical Measurement and Physical Efficiency Test. **At the next stage of selection process, a short list will be published for the Practical Test (Driving Test) by including the candidates who pass in Physical Measurement and Physical Efficiency Test.**

Note:- (5) Candidates included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) no.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018, at the time of OTR verification of original documents.

Note:- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note:- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Copy of answer scripts of the OMR Test held on 17-06-2026 will be issued to those candidates who apply for the same remitting the prescribed fee after the publication of the Ranked List.

Note:- (8) No answer scripts are invalidated as per Notification No : ER 15-1/6/2026-KPSC Dated 10.09.2026 of the Secretary, KPSC, Thiruvananthapuram.
