Applications are invited Online only through One Time Registration from qualified candidates belonging to reservation group of Scheduled Caste Community of Kerala State for appointment in the under mentioned post in Kerala Government Service.

- 1. Department** : **Ayurveda Medical Education**
- 2. Name of Post** : **Assistant Professor in Panchakarma**
- 3. Scale of Pay** : **As per UGC Norms**
- 4. No. of vacancies** : **Scheduled Caste – 01 (One)**

Note : The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the above vacancy earmarked for Scheduled Caste but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 11.04.2017 for the post (Cat. No. 568/2012, Gazette date: 30.11.2012)

- 5. Method of appointment** : **Direct Recruitment (from among candidates belonging to the Scheduled Caste Community only)**

Note:

Applications of candidates belonging to communities other than Scheduled caste will be summarily rejected. Individual communication regarding the rejection of their application will not be issued.

- 6 Age limit** : 20-50. Only candidates born between 02.01.1971 and 01.01.2001 (both dates are included) are eligible to apply for this post. Including relaxation in Part II, Para 2 (i) of General Conditions.

7. Qualifications:-

1. A post graduate Degree in Ayurveda in the concerned subject from any of the Universities in Kerala or from any other Universities recognized by any of the Universities in Kerala.
2. Permanent 'A' class Registration with Travancore-Cochin Medical Council (Council of indigenous Medicine)

Note:- 1. Post-graduate Degree in the concerned subject has been made compulsory for appointment by direct recruitment to the post of Assistant Professor.

2. If post-graduate holders of the subject is not available, post-graduate qualification prescribed by Central Council of Indian Medicine shall be admissible for that subject from time to time.
3. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of the verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
4. In the case of difference in original Caste/Community claimed in the application and that entered in S.S.L.C book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of certificate verification.
5. KS & SSR Part II Rule 10(a)(ii) is applicable.

8. Probation: Every person appointed to this post shall from the date on which he joins duty be on probation for a period of two years on duty within a continuous period of three years.

9. Mode of submitting Application:-

(a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded should be one taken after **31.12.2011**. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link 'Registration Card' in the profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, community etc. have to be produced as and when called for.

(b) If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the

availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

(c) Appropriate disciplinary action as per KPSC **Rules of Procedure, Rule 22** shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.

(d) Candidates who have AADHAAR card should add AADHAAR Card as I.D Proof in their profile.
