- 2 Must possess a valid Motor Driving Licence with endorsement for driving heavy goods vehicles or heavy passenger vehicles with badge.
- 3 Must not be less than 160cms in height (without foot wear). Must not be less than 48kgms in weight and must not be less than 76cms round the chest with a minimum expansion of not less than 5cms.

  - 2 Physical efficiency test will be Conducted by the Commission to assess the physical standards and suitability of the candidates for the arduous nature of work. *Preferential :-* Other conditions being equal, the Home Guard Volunteers who have completed a term of 3 years in that organization and who have satisfactorily undergone training in Fire Fighting during the period of tenure, will be treated as having preferential qualification for direct recruitment to the post.

*Probation*:- Every person appointed to the post shall from the date on which he joins duty, after he completes the training and examination will be on probation for a total period of two years on duty, within a continuous period of three years.

*Training :-* Selected candidates should undergo a course of training for a period of 4 months in the State Fire Service Training School and pass the examination in the subject prescribed for the course.

Note A Written and Practical Test will be conducted at the close of training. Those who fail to qualify themselves at the test, will have their training extended for a period of one month at the end of which, they will be tested again in the subjects in which they have failed. Those who fail to qualify themselves in the re-test will be discharged from service.

Bond Every person appointed to the post shall execute a bond intending to serve the force for a period of not less than 5 years and to pay to Government a sum of Rs. 2,700/- in case of failure to serve in the force for the said period.

- 2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
