Applications are invited Online only from qualified candidates for selection to the under mentioned post in Kerala Government Service.

1. **Department** : Mining and Geology
2. **Name of Post** : Draftsman-cum-Surveyor
3. **Scale of pay** : ₹ 31,100-66800/-
4. **Number of vacancies** : 1 (One)

The above vacancy is now in existence. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancy noted above and also against the vacancies that may be reported to the Commission in writing during the period of currency of the list.

5. **Method of appointment** : Direct Recruitment.
6. **Age limit** : **18-36**, Only candidates born between 02.01.1985 and 01.01.2003 (both dates included) are eligible to apply for this post with usual relaxation to Scheduled Castes, Scheduled Tribes and other Backward Communities. (For other conditions regarding age relaxations please see Para 2 of the General Conditions.)
7. **Qualifications** : 1. SSLC or its equivalent  
2. (i) Surveying and leveling (Higher) KGTE/MGTE  
(ii) Geometrical Drawing (Lower) KGTE/MGTE  
(iii) Mensuration (Lower) KGTE/MGTE  
(iv) Earthwork and Road Making (Higher) KGTE/MGTE  
(v) Building Drawing and Estimating (Higher) KGTE/ MGTE

**OR**

Certificate issued by the Director General of Settlement and Employment in the Surveyor Trade under Draftsman Training Scheme (18 months) Course.

- Note:**
- 1) Rule 10 a (ii) of part II of KS&SSR is applicable.
  - 2) Applications of candidates who have claimed qualifications equivalent to those prescribed in the Gazette Notification for the post will be considered equivalent only if they produce Government Order to prove equivalency at the time of verification.
  - 3) In the case of difference in original caste/ community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/ Community Certificate at the time of certificate verification.

**Probation:** Candidates appointed in this post will be under probation for 2 years within a continuous period of 3 years, from the date of joining duty.

## **8. Mode of submitting applications :-**

- (a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded should be one taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link 'My applications' in their profile. All correspondence with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original Documents to prove qualification, experience, age, Community etc. have to be produced

as and when called for.

- (b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- (c) Appropriate disciplinary action as per KPSC Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
- (d) “Candidates who have AADHAR Card should add AADHAR as ID Proof in their profile.”
