- 2. Five years experience in teaching as Lecturer in Government / Government aided or AICTE approved Polytechnic Colleges.

In the absence of the above qualification, the following qualification will also be considered;

- Degree in the appropriate branch of Engineering/Technology or any other qualification recognised by Government as equivalent there to with not less than 60% marks in the qualifying examination.
- 8 (Eight) years experience in Engineering profession of which atleast 3(three) years should be teaching experience in the subject as Lecturer not below Diploma Level in recognised/approved Institution.
