  - (ii) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to those candidates.
  - (iii) A ranked list will be prepared for the above district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following dates in the following districts.

- (iv) This is the Third NCA Notification for the post owing to non-availability of qualified candidates belonging to the above community, as per First NCA Notification (G.D 16.07.2012, Cat. No. 425/12) and Second NCA Notification (G.D 25.11.2014, Cat. No. 512/14).
- (v) The candidate belonging to above reservation community shall submit application for the post to Ernakulam district where the vacancy is existing for their communities and shall note the name of that district against the relevant column of the online application.
- (vi) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O.(MS) No.154/71/PD dated, 27/05/1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he completes five years continuous service from the date of commencement of service in the former district, Even if transfer is allowed after five years, it will be subject to the rules in G.O.(MS)No.4/61/PDdated02/01/1961. Candidates already in Government service

holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (From candidates belonging to above

reservation communities only.)

6. Age Limit : 21-44. Scheduled Caste candidates born between 02.01.1973

and 01.01.1996 (both dates included) are eligible to apply for this post.[including the relaxation as per para 2 (i) of

General conditions].

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years of age, please see para 2 of general condition under part II of this notification except para 2(i).

## 7. Qualifications:-

- 1) Literacy in Malayalam or Tamil or Kannada
- 2) Must posses Current Motor Driving Licence with endorsement of driving Heavy Duty Vehicle and Motor Cycle and must have three years experience in driving Heavy Duty vehicle either Military or Civil. Driving Licence issued after 16.01.1979 must have endorsement both for heavy Goods and heavy passenger Vehicles and applications with only one endorsement will be summarily rejected (Vide amendment No 47/78 to the Motor Vehicles Act).

Note:- (i)Proficiency in driving Heavy Duty Vehicles will have to be proved at Practical test including H test and Road test conducted by KPSC during the course of selection. Only those who pass 'H' test are eligible for Road test.

- (ii) Candidates must be prepared to clean and oil the Motor vehicles.
- (iii) KS & SSR Rule 10 a (ii) is applicable.
- 3) Medical Fitness:-

- (d) Nervous System- Perfectly normal and free from any infectious diseases.
- 4) Candidate should be Ex-Servicemen/Disembodied Territorial Army personnel (self attested and completed copies of Discharge Certificate and Pension payment Order should be produced when called for).

#### Note:-

- (1) Candidates applying for the post must be prepared to clean and oil the Motor Vehicles and the fact should be noted in the column related to qualification of the application form.
- (2) Selected candidates must be able to drive Light Duty Vehicles also.
- (3) Differently abled candidates are not eligible to apply for the post.
- (4) Candidates should furnish the full details regarding the Driving License and experience in driving in the relevant column (qualifications) of the application form.

- (5) A practical test will be conducted for the selection to this post. In case the number of applications received for this post is unduly large, written Test/OMR Test/Online Examination will be conducted. Those who came out successful for the test will alone be called for the practical test.
- (6) Candidates called for the practical test will have to produce Medical certificate in the prescribed form in original containing all relevant details as required in para 7 (iii) above (except 3 b) from a Medical Officer not below the rank of an Assistant Surgeon. A Medical Certificate regarding eye sight from an Ophthalmologist in Government Service also will have to be produced. (Form of Medical certificate is appended below of this Notification).
- (7) The date of entry in service, date of discharge from service and type of vehicles should be shown in the Experience Certificate. If still in service, the fact should also be mentioned.
- (8) Candidates from the ranked list prepared in response to this notification will be advised for appointment as per turn against Headquarters vacancy also.
- (9) Candidate should possess valid Driving Licence during the entire selection process i.e on the last date of receipt of application, on the date of OMR test, on the date of practical test, interview etc.

Probation:- Every person appointed to the post shall, from the date on which he joins duty be on probation for a total period of 2 years on duty within continuous period of three years.

# 9. Mode of Sending applications:

Candidates must register as per "ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion.
