**FIRST NCA NOTIFICATION**

Applications are invited online only by One Time Registration from qualified candidates belonging to Hindu Nadar reservation community of Kerala State for selection to the under mentioned post.

1. Department : Education
2. Name of Post : High School Assistant (Physical Science) Malayalam Medium.
3. Scale of pay : ₹ 29200-62400/- (Revised)
4. No. of vacancies : District wise  
Hindu Nadar - Kozhikode – 1 (One)  
Kasaragod – 1 (One)

**Note:-**

- (i) Conventional type applications will be summarily rejected. Candidates can apply online only by One Time Registration on [www.keralapsc.gov.in](http://www.keralapsc.gov.in)
- (ii) Applications submitted by candidates belonging to the reservation communities other than those notified will be summarily rejected. No rejection memo will be issued.
- (iii) Separate Ranked list will be prepared for the above districts in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following districts.

- (iv) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he or she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. But as per the GO(P) No 12/96/P&ARD dated 16.3.1996 the condition of 5 years service is not applicable for transfer to Idukki, Wayanad and Kasaragod districts. The concession will be available only for getting transfer to these districts but not for getting transfer out of these districts. And this condition will be granted only once in the career of a Govt Servant. Candidates already in Government service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts

when notified.

(v) Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her. Candidates should note the name of the concerned district against the relevant column of the application.

5. Method of appointment : Direct Recruitment (from candidates belonging Hindu Nadar reservation community only).

6. Age Limit : 18 – 43. Only candidates born between 02.01.1974 and 01.01.1999 (Both dates included) are eligible to apply for this post.  
[The relaxation as per Para 2(i) of General Conditions are included].

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification except para 2 (i).

7. Qualifications:

1) A Degree in the concerned subject and B.Ed/BT in the concerned subject, both conferred or recognized by the Universities in Kerala (Degree in concerned Subjects are specified in Note (iv) below).

2) Must have passed the Kerala Teacher Eligibility Test (K-TET) for this post conducted by the Government of Kerala

**Exemption:** Candidates who have qualified CTET/NET/SET/M.Phil/Ph.D/M.Ed. in the respective subjects are exempted from acquiring TET (G.O. (P) No. 145/16/G.Edn. Dated 30.08.16 and G.O.(P)No.206/16/G.Edn. Dated 08.12.2016).

**Note:-**

(i) M.Phil in the concerned subject be the one awarded by any of the Universities in Kerala or recognised as equivalent by any of the Universities in Kerala.

(ii) Post Graduates in the concerned subject with B.Ed/BT in the concerned subject are also eligible to apply for the post.

(iii) Diploma in Rural Service awarded by the National Council for Rural Higher Education will also be treated as equivalent to Degree for the above purpose.

(iv) The applicant should have taken physics/Chemistry as main subject for graduation. Degree in Geology (Main) with Physics and Chemistry as subsidiary subjects with B.Ed. Degree (Physical Science) can also be considered as an alternative qualification for the post [G.O (Ms) No 195/96/G.Edn dated 2.7.1996].

(v) The candidates who have acquired B.Sc Ed in Physics, Chemistry, Mathematics

stream conducted by the Regional Institute of Education, Mysore of NCERT are also eligible to apply for the post. [G.O(P) No 117/13/G.Edn dt 30.3.13].

- (vi) Post title degree holders are not eligible to apply for the post.
- (vii) If there is a written (Descriptive/OMR) test the Question paper for the written test will be in Malayalam. The candidates should answer the questions in Malayalam. In the case of OMR Answer Script, answers are to be marked as instructed.
- (viii) The disciplines in which B.Sc/M.Sc and B.Ed Degree were obtained should be mentioned in the application.
- (ix) Those candidates who secured B.Ed/B.T Degree from the Universities outside Kerala should note in the application, the number and date of relevant orders declaring the said degree as equivalent to those prescribed for this selection. The copies of such order shall be produced before the commission when it is called for.

NB: Rule 10(a) (ii) of Part II of the KS&SSR will be applicable for this post.

#### 8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT

- (i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated 12.02.1970 and G.O.(MS) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term `Jawans'. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).
- (ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975).
- (iii) Teachers of the Government Primary and Nursery Schools who are graduates and are otherwise qualified will be exempted from upper age limit (G.O (Ms) No 185/70/Edn dated 18.4.1970 and G.O (Ms) No 466/70/Edn dt 11.11.1970). They should produce proper certificates from authorities concerned as and when required by the Commission.

Note:- The candidates who are eligible for the above preferences or concessions in upper age limit or concessions by virtue of any of the reason mentioned in Para 2 of the General Condition (except para 2 (i)) should claim the same through the “weightage and preferences” link provided in their One Time Registration Profile and give details in the space provided. The applications of candidates who are eligible for concession in upper age limit and who do not claim the same, are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age (see para 2 of General Conditions).

10. Mode of Sending Application :

Candidates must register as per “ ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered shall apply by logging in to their profile using their user ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading of the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates can view the details in their profile by clicking the link 'Registration Card' in their profile. A print out of the same can be taken if needed. Candidates are responsible for the correctness of the personal information and secrecy of password. Before final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User ID for further communication with the Commission. Application once submitted is provisional and cannot be deleted or altered after submission. Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, community, Age, etc., have to be produced as and when called for. **“Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile”.**

12. If written (Descriptive/OMR/Online) Test is conducted as a part of the selection Admission Tickets of eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
