6. Age

- : <u>1)For SC Candidates:</u> 18-45. Only candidates born between 2.1.1972 and 1.1.1999 (both dates included) are eligible to apply for this post. (including the relaxation as per Para 2 (1) of the General condition).
  - **2)** For OBC Candidates:- 18-43. Only candidates born between 2.1.1974 and 1.1.1999 (both dates included) are eligible to apply for this post. (including the relaxation as per Para 2 (1) of the General condition.)

## Note:-

For conditions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, [please see para (2) of the General Conditions under Part II of this Notification]. Relaxation of age will be allowed to all provisional employees of the Twenty Nine Co-operative Institutions mentioned in G.O.(P) No.41/98 dated 09.03.1998 (whether they continue in service or relieved from service) who have been appointed through the Employment Exchange to the extent of their provisional service provided they possess a minimum service of One year in the provisional appointment.
