Note: (i) Conventional type applications will be summarily rejected. Candidates shall apply online only by One Time Registration to www.keralapsc.gov.in.

- (ii) In the absence of suitable candidates, the vacancies set apart for By Transfer recruitment shall be filled up by the candidates from the Ranked List prepared for Direct recruitment.
- (iii) The applicant should be an approved probationer/Full member of the Kerala General Education subordinate service as on the date of application.
- (iv) Separate Ranked Lists will be prepared for each district in pursuance of this notification. The Ranked lists thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (v) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD, dated 02.1.1961. But as per the GO(P) No 12/96/P&ARD dated 16.3.1996 the condition of 5 years service is not applicable for transfer to Idukki, Wayanad and Kasaragod districts. The concession will be available only for getting transfer to these districts but not for getting transfer out of these districts. And this condition will be granted only once in the career of a Govt Servant.

Candidates already in Government service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- (vi) Applications should not be submitted to more than one district in response to this If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her. Candidates should note the name of the concerned district against the relevant column of the application.
- (vii) The rules regarding the reservation of appointment contemplated in Article 14 to 17 in Part II of the KS & SSR are not applicable to recruitment by transfer.

5. Method of appointment : Recruitment by transfer from among the employees who have completed the prescribed service and who are working as Clerk/Typist/Attender/Office Attendant in the General Education Department.

7. Qualifications:-

- 1) A Degree in the concerned subject and B.Ed/BT in the concerned subject conferred or recognized by the Universities in Kerala. (Degree in Concerned subjects are specified in Note (iii) below.)
- 2) Must have passed the Kerala Teacher Eligibility Test (K-TET) for this post conducted by the Government of Kerala

Exemption: Candidates who have qualified CTET/NET/SET/M.Phil/Ph.D/M.Ed. in the respective subjects are exempted from acquiring TET (G.O. (P) No. 145/16/G.Edn. Dated 30.08.16 and G.O. (P) No. 206/16/G.Edn. Dated 08.12.2016).

Note:-

- M.Phil in the concerned subject be the one awarded by any of the Universities in Kerala or recognised as equivalent by any of the Universities in Kerala.
- (ii) The Employees of the General Education Department who have completed the prescribed service and who are working as Clerk/Typist/Attender/Office Attendant can apply to the above post even if they have not passed the Kerala Teacher Eligibility Test (K-TET) subject to the condition that they should acquire the K-TET qualification within 31.03.2018 (G.O. (P) No. 7/2017/G.Edn. Dated 07.04.2017)
- (iii) The applicant should have taken Botany or Zoology or Home Science or Micro Biology as main subject for Graduation/Post graduation.
- (iv) Diploma in Rural Service awarded by the National Council for Rural Higher Education will also be treated as equivalent to Degree for the above purpose.
- (v) The candidates who have acquired B.Sc Ed in Chemistry Botany Zoology stream conducted by the Regional Institute of Education Mysore of NCERT are also eligible to apply for the post (GO (P) No 117/13/G Edn dtd 30/3/13).
- (vi) B.Ed in Life Science awarded by any of the universities in kerala through a regular course of study or B.Ed in Life Science awarded by universities outside kerala through a regular course of study which is recognised as equivalent to B.Ed in Natural Science by any of the universities in kerala will also be accepted as sufficient training qualification for the post. (GO (MS) No 46/2011/G Edn dtd 22/02/2011, GO (MS) No 145/2012/G Edn dtd 09/05/2012)
- (vii) The disciplines in which B.Sc/M.Sc and B.Ed Degree were obtained should be mentioned in the application.

- (viii) If there is a written (Descriptive/OMR) test the Question paper for the written test will be in Malayalam. The candidates should answer the questions in Malayalam. In the case of OMR Answer Script, answers are to be marked as instructed.
- (ix) Those candidates who secured B.Ed/B.T Degree from the Universities outside Kerala should note in the application, the number and date of relevant orders declaring the said degree as equivalent to those prescribed for this selection. The copies of such order shall be produced before the commission when it is called for.

Candidates must register as per "ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered shall apply by logging in to their profile using their user ID and password.
