7. **Qualifications**: 1. Literacy in Malayalam or Tamil or Kannada.

2. Possession of current Syrang Licence.

Note: 1. Candidates should possess current Syrang Licence through out all the stages of selection process as on the last date for receipt of application, OMR Test, practical test, interview etc.
