Only candidates born between 02.01.1976 and 01.01.1999 (both dates included) are eligible to apply for this post in the case of SC, ST and O.X candidates who have converted to Christianity from SC communities after attaining the age of eighteen years and the children of such parents. [Including the relaxation as per para 2 (i) of General Conditions].

7. Qualifications:- (a) General.

A pass in Pre-Degree or equivalent examination with not less than 50% marks or B grade in science subject. Relaxation of 10% marks will be allowed to those belonging to Scheduled Caste/Scheduled Tribe and 5% marks to socially and Educationally Backward communities who come under the purview of GO.(P) 208/66/PD dt 21.5.1966 and subsequent orders/amendments.

S.S.L.C or equivalent for Ex-servicemen who have passed Class I Blood Transfusion Assistant Test and have put in not less than 15 years service in the Armed Forces.

## (b) Technical.

A pass in one year Medical Laboratory Technician's Training Course conducted by the Medical Colleges in Kerala or by the Public Health Laboratory, Thiruvananthapuram or any qualification equivalent there to.

- Note :- (i) In the case of persons who have completed Degree course in Science, `B' Grade in Pre-degree examination will not be insisted.
  - (ii) KS & SSR Part II Rule 10 (a) (ii) is applicable for selection to this post.
- **8.** Mode of submitting Applications :-
