## ORDER

As per Rule 6 of the Special Rules of State Archives Department read as first & second papers above the method of appointment for the Superintendent is prescribed as follows:-

Superintendent

By transfer from the categories of Assistant Superintendent and Assistant Archivist in the Department

Essential:- Experience as Assistant Superintendent or Assistant Archivist in the Department for a period of not less than five years.

Desirable:- (i) Proficiency in old scripts and Malayalam.

(ii) Training in Archive at National Archives.

Essential:- A first or second class degree in History with Indian History as a special subject, of any recognised University in India.

Desirable:- (i) Training in National Archives or in any State Archives in India.

(ii) Proficiency in old scripts and Malayalam.

Direct recruitment

Director, Archives Department has reported that at present no departmental officers having 5 years experience in feeder category of Superintendent post is available and instead all of them have only two years of experience. The post of Superintendent cannot be kept vacant for a long period, it being designated as the head of the office and Drawing and Disbursing Officer of Regional Archives. In the above circumstances, invoking General Rule 39 of the Kerala State Subordinate Service Rules, Government are pleased to amend the Rules in respect of the method of appointment of Superintendent (by transfer) as shown below, in relaxation of the present special rules:-

Category

Method of Appointment

Qualification

By transfer from the Categories Assistant Superintendent, Assistant Archivist Grade-I and Junior Editor in the Department

Essential:- On completion of the Probation (Minimum one year) in the feeder category viz., Assistant Superintendent, Assistant Archivist Grade-I and Junior Editor in the Department

- 3. Upon consultation, the Kerala Public Service Commission has concurred to the issuance of executive orders to cope with this exigency pending formal issuance of statutory amendment vide letter read as 4th paper above.
- Formal statutory amendments to Special Rules to this effect will be issued separately.
- 5. The Government Orders read above stands modified to this extent.
