ORDER

In the Government Order read as 1st paper above, orders have been issued unifying the date of retirement of Government employees and teachers as 31st March or till the end of the academic year for teachers having different dates of closing of academic year. In the Government Order read as 2nd paper above, instructions have been issued for filling up the vacancies that would have arisen but for the unification of the date of retirement, by creating supernumerary posts at the relevant entry level. Vide letter read as 3rd paper above, Government reiterates that this delegation of creation of supernumerary posts is a special dispensation for this limited purpose and for retirement vacancies that are affected due to the unification of the date of retirement only. Vide Circular read as 4th paper above, all appointing Authorities/Heads of Department are I directed to assess the vacancies that would have arisen during the entire financial year, but for unification of the date of retirement and create that number of posts at the entry leverand report the vacancies to Kerala Public Service Commission.

2. Accordingly, each Head of the Department/ Administrative Department is required to assess retirement vacancies office wise and category wise and to identify the espective entry cadre posts and create supernumerary posts for the financial year to ensure that entry level recruitment is not affected and to report to KPSC for the advice of candidates. The Advocate General vide letters read as 6th paper above intimated the vacancies that would have arisen but for the unification of the date of retirement and requested to create corresponding entry level supernumerary posts in the Office of the Advocate General.

3. In exercise of these powers, Goyt. are pleased to create supernumerary posts as detailed in column (5) in the table below for the financial year 2011-2012 in the Office of the Advocate General.
