Applications are invited online only from qualified candidates for appointment in the under mentioned post in Kerala Government Service. Before applying for the post candidates should register as per the One Time Registration through the official website of Kerala Public Service Commission.

1. Department : Industrial Training
2. Name of Post : Junior Instructor (Surface Ornamentation Technique)
3. Scale of pay : ₹ 13900-24040/-
4. No. of vacancies : 2 (Two)

The above vacancies are now in existence. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies noted above and the vacancies that may be reported to the Commission in writing during the period of currency of the list.

Note:- 3% of vacancies will be reserved for persons with differently abled (Locomotor disability/cerebral palsy, Hearing impairment, Low vision) as per G.O(P)1/13/SJD dated 03.01.2013.

5. Method of appointment : Direct Recruitment
6. Age limit : 19 - 44
Only candidates born between 02.01.1972 and 01.01.1997 (both dates included) are eligible to apply for this post with usual relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities. (for other conditions regarding the age relaxation please see para 2 of the General Conditions)

7. Qualifications:

1. S.S.L.C or its equivalent qualification.

And

2. (a) National Trade Certificate in the appropriate trade with 3 years experience in the trade after obtaining the certificate.

OR

(b) National Apprenticeship Certificate in the appropriate trade with one year experience after obtaining the Certificate.

OR

(c) Diploma in the appropriate branch of Engineering from a Government or Government recognized Polytechnic or its equivalent qualification.

Note:-

1. Rule 10(a)(ii) of Part II of KS & SSR is applicable.

2. The experience gained by a Workshop Attender can also be deemed to be qualifying experience in the trade for selection to this post.

3. Candidates belonging to SC/ST are exempted from the qualification of experience.

8. **Probation** : Every person appointed to this post shall, from the date on which joins duty, be on probation for a total period of two years of duty within a continuous period of three years.

9. Mode of submitting Applications :

Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by login on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their

profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.

If a Written/OMR Test is conducted as part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
