Applications are invited Online only by “ONE TIME REGISTRATION” from qualified candidates belonging to reservation group of Scheduled Caste community of Kerala State for appointment in the under mentioned post in Kerala Government Service.

1. **Department** : Drugs Control
2. **Name of Post** : Analyst Gr.III
3. **Scale of pay** : ₹ 11070-18450/-
4. **Number of vacancy** : Scheduled Caste – 1 (One)

The above vacancy is now in existence. 5. **Method of appointment** : **Direct Recruitment** (From among candidates belonging to the Scheduled Caste community only).

NOTE: Applications of candidates belonging to communities other than Scheduled Caste will be summarily rejected. Individual communication regarding the rejection of their application will not be issued.

6. **Age Limit** : **21-41** [Only candidates born between 02.01.1975 and 01.01.1995 (both dates included) are eligible to apply for this post. [Including the relaxation as per para 2(i) of the General conditions.]

7. Qualifications

Degree in Pharmacy of a recognised University

1. Direct recruits shall be on training for six months from the date of joining in service. Probation shall commence after successful completion of training

8. Mode of submitting Applications:

Candidates must register as per “ONE TIME REGISTRATION” with the Official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply now' button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded should be taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote User-Id for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The applications will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, Experience, community, age etc have to be produced as and when called for.
