B.Sc Degree in Zoology from a recognised university with two year Diploma in Dairy Development from a recognised institution.

OR

Degree in Veterinary Science from a recognised university

OR

Post Graduate Diploma in Dairy Development or equivalent from a recognised institution.

A pass in Vocational Higher Secondary Course in Livestock Management (Dairying) conducted by Government of Kerala or equivalent and B.Sc Degree with Zoology as an optional subject awarded by any of the universities in Kerala or an equivalent qualification.

- Note:- 1) All the educational qualifications should be one acquired after a regular course of study from a recognized University in Kerala or recognized as equivalent thereto by any one of the Universities in Kerala.
 - 2) The total number of sanctioned posts shall be filled up by the methods viz (1) by promotion (2) by transfer and (3) by direct recruitment in the ratio 2:1:7. If sufficient number of qualified persons are not available under by promotion and by transfer method such vacancies shall also be filled up by direct recruitment method. [GO(P) No.81/2004/Gl. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.
