- (ii) Separate ranked list will be prepared for each district in pursuance of this notification. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancy noted above and the vacancies that may be reported to the Commission in writing during the period of currency of the list. In case no candidate is advised from the ranked lists till the expiry of the period of one year or till at least one candidate is advised from the list whichever is earlier.
- (iii) Candidates who are eligible to apply for both direct recruitment and recruitment By transfer need not select the same district for both categories but they should submit separate applications for each category even if they selected the same district candidates who are included both list under this notification and advised from anyone of the list shall be deleted from the other list as per Rule 18 (iii) of the Kerala Public Service Commission rules of procedure.
- (iv) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he or she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of : Recruitment by transfer (District wise) Appointment

(i) Applications are invited from among any category of persons in the last grade service in the excise department. Recruitment by transfer shall be made in the ratio of 3:1 against vacancies reserved for last grade servants in the excise department as per GO

- (P) No.36/80/TD dated.28.04.80. In the absence of qualified hands for appointment by transfer the vacancies shall be filled from ranked list prepared for direct recruitment.
- (ii) For recruitment by Transfer from among any category of persons in the Last Grade Service in the excise department. The applicants should obtain a certificate from the Head of the Department or office showing their service particulars in the form given below uploaded the certificate in their profile and produce the same as and when required by the commission. Persons appointed through Employment Exchange or otherwise and working on a temporary/provisional basis are not eligible to apply for this post.

Note: Proficiency in Driving Heavy Goods & Heavy Passenger Motor Vehicles will be examined by a Practical Test (H - test and Road test) conducted by Kerala Public Service Commission during the course of selection. Only those who have passed the 'H'- test are eligible for Road Test
